

## Muslim Hands Qurbani Project-2020

### Tender Specification for the provision of Animals

Muslim Hands is an international relief and development organization established in 1993. Muslim Hands Pakistan Chapter is registered with Ministry of Interior, Government of Pakistan (No. 4/113/2016-PE-III) with presence in more than 60 districts across the country through 2 Regional and 11 Area offices in AJ&K, Punjab, KP, Sindh & Baluchistan.

Every year Muslim Hands targets the most deserving communities through its Qurbani Project to address the issues of malnutrition.

In this regard, **the regional / area office Mirpur Azad Kashmir** of Muslim Hands Pakistan intends to hire services of a vendor for the provision of sacrificial animals and other associated services for its Qurbani project 2020.

#### **Animal Specifications**

Health and Age	Healthy, age, 2.5 to 4 years as per Shariah law
Qurbani Animals (Cows/Buffaloes)	<ul style="list-style-type: none"><li>- Type: Cow/Buffalos (Pregnant Cow is not eligible for sacrifice)</li><li>- Weight: 100 KG net clean meat after slaughtering, skinning &amp; cutting (exclusive of head, feet, liver, heart and animal waste)</li><li>- Age: 2-4 Years (With visible Minimum two (2)- Maximum six (6) Teeth.</li></ul> Major Requirements: <ul style="list-style-type: none"><li>- Animal should not have any physical defects and disease i.e. Congo virus blindness, missing/ broken limb, and damaged horns or any other disability.</li><li>- Animals should be healthy, active and fit for Qurbani as per Shariah laws.</li><li>- If any of the animal seems weak or with any physical defect of any kind, will not be acceptable and vendor has to provide alternate animal.</li><li>- Only 20% female (must not be pregnant) animal are acceptable.</li></ul>

## **Required Services and Other Requirements**

The selected vendor must provide all of the following services during the Qurbani project 2020.

- Provision of **50 no of animals** to **regional/area office Mirpur Azad Kashmir** on the following locations

<b>Location</b>	<b>Number of Animals</b>
<b>Mirpur Azad Kashmir</b>	<b>50</b>

- Slaughtering of animals as per Shariah Law on the first three days of Qurbani.
- Skinning of animals, cleaning and removal of animal waste. - Cutting of meat into small pieces minimum 16-pieces/per kg.
- The clean meat will be weighted, and if the average weight is less than 100/kg per animal, the vendor will have to complete this by any mean, and no amount will be deducted / adjusted if the meat weight is less, only additional meat is acceptable at the site / Eid day.
- Packing of meat, 3-4 kg pack (food graded poly bag) and tie knotting.
- The vendor is responsible to clean up the site/venue.
- The butchers provided for sacrifice and cutting of meat must be professional and trained.
- All the left-over parts i.e. skin, head, feet, etc. will be property of Muslim Hands.
- Animal must be supplied at the aforementioned sites in the respective quantities before 72 hours, and will be examined before 48 hours of Eid in the presence of vendor/representative.

## **Eligibility Criteria for Vendors**

- Registered with FBR.
  - Valid NTN/ CNIC.
  - Active Tax Payer.
  - Company Profile (if applicable).
  - Bank Account Details.
  - All prices/details should be mentioned (Size of animal, Transportation charges, etc).
  - All prices should be inclusive all taxes.
- 
- The interested vendor may submit 5% CDR (in the name of Organization) of the total value of the quoted bid price. (the CDR of the unsuccessful vendors will be returned within 10 working days)

- Only WHT may be included in the bid price (GST not chargeable).

### **Animals Welfare**

Cows/Bulls procured for Qurbani will be screened out through a qualified veterinary doctor and the vendor will must be responsible for the animals welfare i. e. provision of fodder and water till the first, second and third day of Eid.

### **Deadline for Submission of Bids**

- The deadline for the submission of bids is **8<sup>th</sup> of July, 2020**.

### **Payment guidelines**

- All the payments of project will be disbursed through cross cheques and according to the procurement policy of Muslim Hands.
- 30% cost of total bid will be paid after completion of project.
